NovEx Novice to Expert Learning, LLC ("NovEx", the "Company", "we", or "our") respects your privacy and is committed to protecting it through our compliance with this policy.

This policy describes the types of information we may collect from you or that you may provide when you visit the website novicetoexpert.org (our "Website") and our practices for collecting, using, maintaining, protecting, and disclosing that information. # Information We May Collect

**Personal Information** – We collect information that you provide, such as your name, email address, telephone number, physical address, and online identifiers.

Although this information helps us to communicate with individuals and to improve our programs, you have no obligation to provide personal information. However, your refusal to provide needed information may prevent you from accessing, using, and receiving reports from NovEx.

### Activity Data -

Like most websites, NovEx may collect data about a user's browsing behaviors on the NovEx website, such as which pages you visit, what links you click, and what articles you download, etc. We use this data to provide a personalized NovEx experience and deliver information that is most useful and salient to you. We and our third party online companies may collect technical information from your computer or mobile device when you use our services.

Other Automatically Collected Data – We may collect information that enables us to track the use of our web pages at a de-identified and aggregate level, as a way of improving the web experience. We may use and share this de-identified data for any purpose at our discretion.

### How We Collect Information

#### **Learner Provided Data**

We may require that you provide your information when you request information about our services, schedule a demo, login on our site, complete registration, use our programs, progress through specific content, subscribe to a newsletter, respond to a survey, fill out a form, provide us with feedback on our products or services, attend an event, or enter information on our site.

### **Data Obtained from Adobe Captivate**

We have used and integrated Adobe Captivate to create our eLearning simulations. We draw data from Adobe Captivate, which tracks End Users' activities, to provide the User's performance and progress. You will be subject to Adobe's privacy and security practices, which may differ from ours. You should familiarize yourself with Adobe's privacy policy, terms of use, and security practices.

#### **Data Obtained from Third Party**

We may use data that is publicly available or data provided by third party resources. We may collect information received from a subscribing organization when you use a NovEx program that was obtained for you by your employer, a healthcare system, or organization.

### **Analytics Tracking**

We may use web analytics code to track and collect data about your patterns of web use and online behaviors whenever you visit the NovEx website and our programs, to better serve your needs and interests.

#### **Cookies**

We may use small amounts of code to track your visits and may include cookies.

Cookies are small files transferred to your computer that allows the service provider's systems to recognize your browser and capture and remember certain information. Cookies help us with functions such as remember and process your shopping cart items, provide customized services, save your preferences for future visits and collect data about site traffic so that we may improve site experiences and information in the future. We may also employ trusted other services that track this information on our behalf.

### When We Share Data

#### For Third Party Analytics & Benchmarking

We may disclose any of your Information that we collect to trusted third parties that perform certain analyses and functions on our behalf, such as to provide analytics on Activity Data, website usage information, process our transactions and payments, provide outsourced assistance with the operations of the Web Service functions, and provide services that assist with the operation of our business.
